Purpose

The purpose of this Ethical Supply Chain Policy is to:

 - Promote sustainable practices and respect for human rights throughout our supply chain.

Scope

This policy applies to all suppliers, subcontractors and business partners of CIE-Group, as well as our employees and stakeholders involved in supply chain management. It encompasses all activities, from sourcing components to the delivery of finished products and services.

Core Principles

1. Compliance with Laws and Regulations

All suppliers and business partners must adhere to:

- Applicable local, national and international laws and regulations, including those related to labour, trade and the environment.

2. Human Rights and Fair Labour Practices

We expect all suppliers to respect and uphold the fundamental rights of workers. This includes:

- Prohibition of child labour, forced labour and human trafficking.
